Liability Release Form

In consideration for being permitted to participate in said instruction and training:

- 1. I hereby release, waive, discharge, and covenant not to sue, Michael Wanzenried, each and every agent, employee or rider thereof, and the sponsor or sponsors named above, all for the purposes herein referred to as "releasees", from all liability to myself, my legal representative, distributes, guardians, assigns, heirs, and next of kin, all for purposes herein referred to as "releasors", for injury, death, or damage resulting from my participation in said instruction and training as a result of the negligence of releasees, or any employee, servant, agent, or contractor of releasees. I further release and discharge releasees from all liability to releasors for injury, death or damage resulting from my participation in said instruction and training as a result of the negligence of any other party or parties in attendance. In addition, I hereby release and discharge releasees from all actions, claims or demands releasors now have or may hereafter have for injury, death, or damage resulting from my participation in such activities.
- 2. I hereby agree to indemnify and save and hold harmless releasees and each of them, from any loss, liability, damage or cost they, or any of them, may incur due to my participation in said instruction and training.
